**A RESOLUTION APPROVING THE AMENDED COMPREHENSIVE BARANGAY
YOUTH DEVELOPMENT PLAN FOR FY 2025 OF THE SANGGUNIANG KABATAAN
OF BARANGAY MATANDANG BALARA, DISTRICT III, QUEZON CITY**

WHEREAS, Article 2, Section 12 of the 1987 Philippine Constitution states that “the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs;

WHEREAS, Republic Act No. 10742, also known as the Sangguniang Kabataan Reform Act of 2015, as amended by RA 11768 stipulates in, Section 8, Paragraph A, that “In consultation and with the concurrence of the Katipunan ng Kabataan, and within three (3) months from assumption to office, formulate a three (3)-year rolling plan, which shall be known as the Comprehensive Barangay Youth Development Plan, which shall serve as basis in the preparation of the Annual Barangay Youth Investment Program. This plan shall be aligned with the Philippine Youth Development Plan (PYDP) and other Local Youth Development Plans at every level, municipal, city, and provincial as is relevant;

WHEREAS, the previous council of the Sangguniang Kabataan of Barangay Matandang Balara formulated the Comprehensive Barangay Youth Development Plan for 2023 to 2025 on the 17th day of January 2023 for the 2023 Annual Budget;

WHEREAS, a precise review and amendment process was undertaken to ensure the relevance and effectiveness of the desired programs, projects, and activities, outlined in the aforementioned Comprehensive Barangay Youth Development Plan for 2023 to 2025;

WHEREAS, due to some changes in the Youth Development Plans for 2024 to 2025, the Comprehensive Barangay Youth Investment Plan for FY 2023 to 2025 has been amended, formulated, and diligently crafted as the Amended Comprehensive Barangay Youth Development Plan for FY 2024-2025 as approved in Resolution No. 5 Series of 2024, dated April 05, 2024;

WHEREAS, upon the advice of the Quezon City Youth Development Office, and the diligent review of the council, further amendments have been made in reference to the needs of the youth of Barangay Matandang Balara, leading to the formulation of the Amended Comprehensive Barangay Youth Development Plan for FY 2025

WHEREAS, the Amended Comprehensive Barangay Youth Development Plan for FY 2025 shall be comprehensive and rationalized, encompassing all the fund sources of projects and vital concerns, as in line with the Quezon City Local Youth Development Plan, and the Philippine Youth Development Plan;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Amended Comprehensive Barangay Youth Development Plan of the Sangguniang Kabataan of Matandang Balara, District III, Quezon City for Fiscal Year 2025 to 2026 is hereby approved.

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned government offices for their record and reference purposes.
