A RESOLUTION APPROVING THE 2026 ANNUAL BARANGAY YOUTH INVESTMENT PROGRAM (ABYIP) OF BARANGAY MATANDANG BALARA, DISTRICT III, QUEZON CITY AMOUNTING TO ELEVEN MILLION FOUR HUNDRED SEVENTY-ONE THOUSAND ONE HUNDRED NINETY-TWO PESOS AND FIFTY-SIX CENTAVOS ONLY (P11,471,192.56) AND APPROPRIATING ELEVEN MILLION FOUR HUNDRED SEVENTY-ONE THOUSAND ONE HUNDRED NINETY-TWO PESOS AND FIFTY-SIX CENTAVOS ONLY (P11,471,192.56)

WHEREAS, Article 2, Section 12 of the 1987 Philippine Constitution states that "the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs;

WHEREAS, the amended Implementing Rules and Regulations of Republic Act No. 11768, amending Republic Act No. 10742 also known as the Sangguniang Kabataan Reform Act of 2015, provides in Section 8, Paragraph A, states that, in consultation and with the concurrence of the Katipunan ng Kabataan, and within three (3) months from assumption to office, formulate a three (3)-year rolling plan, which shall be known as the Comprehensive Barangay Youth Development Plan, which shall serve as basis in the preparation of the Annual Barangay Youth Investment Program. This plan shall be aligned with the Philippine Youth Development Plan (PYDP) and its Local Youth Development Plans in every level, municipal, city, and provincial as is relevant;

WHEREAS, Republic Act No. 10742, also known as the Sangguniang Kabataan Reform Act of 2015, provides in Section 20, Paragraph C, states that all Sangguniang Kabataan funds shall be allocated in an annual budget, and if the funds allow, in a supplemental budget in accordance with the adopted Annual Barangay Investment Program. Both the Comprehensive Barangay Youth Development Plan and Annual Barangay Investment Program shall give priority to programs, projects, and activities that will promote and ensure the equitable access to quality education, environmental protection, climate change adaptation, disaster risk reduction and resilience, youth employment and livelihood, health and anti-drug abuse, gender sensitivity, sports development, and capability building which emphasizes leadership training;

WHEREAS, Chapter II, Section 20, Paragraph A of Republic Act No. 10742, also known as the Sangguniang Kabataan Reform Act of 2015, states that Ten Percent (10%) of the general fund of the Barangay shall set aside for the Sangguniang Kabataan. The Sangguniang Kabataan shall appropriate the SK funds in lump-sum which shall be disbursed solely for youth development and empowerment purposes;

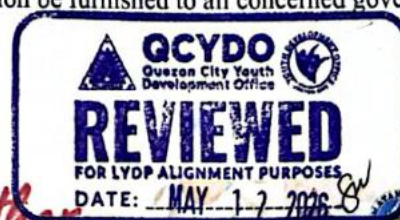
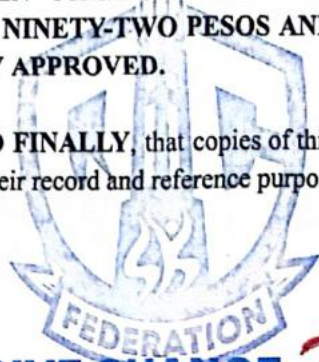
WHEREAS, the total budget of the Sangguniang Kabataan of Matandang Balara shall be Eleven Million Four Hundred Seventy-One Thousand One Hundred Ninety-Two Pesos And Fifty-Six Centavos Only (P11,471,192.56);

WHEREAS, the Sangguniang Kabataan of Barangay Matandang Balara has prepared the 2026 Annual Barangay Youth Investment Program, in accordance with the approved Comprehensive Barangay Youth Development Plan for Fiscal Year 2026 to 2028;
