RESOLUTION NO. 03 S-2021

A RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY MATANDANG BALARA SANGGUNIANG KABATAAN FOR THE FISCAL YEAR 2021 INVOLVING THE SUM OF NINE MILLION THREE HUNDRED ELEVEN THOUSAND SIX HUNDRED EIGHTY NINE PESOS AND FIFTY NINE CENTAVOS (PHP9,311,689.59).

WHEREAS, Article 2, Section 12 of the 1987 Philippine Constitution provides that "the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social; well-being. It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs".

WHEREAS, Chapter II Section 8 paragraph (a) of The Implementing Rules and Regulations of Republic Act 10742 also known as the Sangguniang Kabataan Reform Act of 2015 provides that "In consultation and with the concurrence of the Katipunan ng Kabataan, formulate a three (3) year rolling plan, which shall be known as the Comprehensive Barangay Youth Development Plan, which shall serve as basis in preparation of the Annual Barangay Youth Investment Program."

WHEREAS, Chapter II, Section 20, paragraph (a) in RA 10742 or also known as the Sangguniang Kabataan Reform Act of 2015 states that "TEN PERCENT" (10%) of the general fund of the Barangay shall set aside for the Sangguniang Kabataan. The Sangguniang Kabataan shall appropriate the SK funds in lump-sum which shall be disbursed solely for youth development and empowerment purpose".

WHEREAS, funds shall be appropriated from the ten percent (10%) Sangguniang kabataan Fund for 2021 amounting to NINE MILLION THREE HUNDRED ELEVEN THOUSAND SIX HUNDRED EIGHTY NINE PESOS AND 59/100 ONLY (PHP9,311,689.59) solely for youth development and empowerment purposes only.
