SK RESOLUTION NO. 01 -S-2021

A RESOLUTION AMENDING THE APPROVED COMPREHENSIVE BARANGAY YOUTH DEVELOPMENT PLAN (CBYDP) FOR 2020 TO 2022 OF THE SANGGUNIAN KABATAAN OF BARANGAY MATANDANG BALARA, DISTRICT III, QUEZON CITY FOR THE INCLUSION OF ADDITIONAL PROJECTS, BETTERMENT OF YOUTH SERVICE IN THE BARANGAY AND FOR OTHER PURPOSES

WHEREAS, Article 2, section 12 of the 1987 Philippines Constitution states that "the state recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social; well-being. It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs."

WHEREAS, Implementing Rules and Regulations of Republic Act 10742 also known as the Sangguniang Kabataan Reform Act of 2015 provides in chapter II, section 8, paragraph (a) states that "In consultation and with the concurrence of the Katipunan ng Kabataan, and within three (3) months from the assumption of office, formulate a three (3)-year rolling plan which shall be known as the Comprehensive Barangay Youth Development Plan (CBYDP)."

WHEREAS: Chapter II, Section 20, Par (a) in RA 10742 or also known as the Sangguniang Kabataan Reform Act of 2015 states that "Ten Percent (10%) of the general fund of the barangay shall set aside for the Sangguniang Kabataan. The Sangguniang Kabataan shall appropriate the SK funds in lump-sum which shall be disbursed solely for youth development and empowerment purposes."

WHEREAS, the Comprehensive Barangay Youth Development Plan (CBYDP) of the Sangguniang Kabataan of Barangay Bagumbayan was reviewed and approved by the offices concerned and by the City Council last 2020.

WHEREAS, the Sangguniang Kabataan of Barangay Horseshoe has seen the need to amend the Approved Comprehensive Barangay Youth Development Plan for 2020-2022 for the inclusion of additional projects, betterment of youth service in the barangay and to provide the basic necessities needed by the youth.

WHEREAS, the amendments in the CBYDP are hereunder specified and provided;
